OUR ENTRY REQUIREMENTS

Applicants must meet the following requirements:

- KCSE minimum mean aggregate of B with a minimum grade of B in English.
- 6 credits at O-level, A level 3 principal passes
- IB Diploma 34 points out of 45

Proof of above-mentioned qualifications and grades should be sent in the form of scanned copies of the KCSE certificate.

Interviews are held on Wednesdays between March and June at 8:00 am.

Candidates are required to bring originals and copies of relevant academic certificates, 2 passport size photographs, a photocopy of birth certificate or National ID or passport and Ksh 2,000 entrance exam fee.

Intake for the programme is July. Duration of the course is 4 years.
